By accessing our website www.fsg.pl, you entrust your personal data to us so that we can process them for particular purposes, always taking utmost care of your privacy. This Privacy Policy is for you to understand what data we collect, why we do it, and how we use them.

This information concerns you. We kindly ask you to become familiar with the document.

Our privacy policy is of strictly informational nature, which means it imposes no obligation on you. It serves to inform you to what extent and to what end we process your personal data acquired through the tab www.fsg.pl/broker/oferta-brokerska.

2. INFORMATION ABOUT PERSONAL DATA CONTROLLER

The Controller of the personal data acquired through the tab www.fsg.pl/broker/oferta-brokerska is FSG Broker Sp. z o. o. with its registered office at Plac Andersa 3, 61-894 Poznań, hereinafter referred to as the Controller.

We represent that all personal data are processed in accordance with:

- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC,
- Act on the protection of personal data of 10 May 2018 (Dz. U. [Journal of Laws]. 2018 item 1000);
- Act on the provision of services by means of electronic communication of 18 July 2002 (Dz. U. [Journal of Laws] 2017 item 1219 as amended).

We endeavor to protect your interests and guarantee that the data we collect are processed lawfully. They are collected for particular and legitimate purposes; no data are further processed against these purposes; they are substantially correct and adequate to the purpose we collect them for, set forth in this privacy policy; they are stored in a manner that in no way allows identification of the persons they refer to, and no longer than necessary to achieve the purpose of their processing.

3. PURPOSE AND SCOPE OF COLLECTING DATA AND DATA RECIPIENTS

The scope of data processing and the recipients of the data processed by the Personal Data Controller depend on the actions undertaken for your benefit. For instance, if you wish to send us a question, you may be asked to provide your personal data within a particular scope.

Purpose of collecting personal data

We collect your data for one of the following purposes:

- To personalize the website so as to meet your particular needs and interests. To this end, our tab uses cookies, which allow us to understand your preferences concerning the website, modify the way it is presented, and update it according to your needs and expectations.
- To allow you to contact us and discuss particular issues using the given e-mail address, and to respond promptly and professionally. To this end, we may ask you to provide various groups of data depending on the topic you have chosen. The scope of data collection is adequate to the purpose we want to achieve, e.g. if you wish to share your opinion concerning our services with us, there is no need to provide your postal address or telephone number; it will suffice to share only your first name and e-mail address, so that we can reply to you if you so wish.

- first and last name;
- IP address;
- e-mail address;
- telephone number.

We may also process anonymous usage data related to the accessing of our tab (so-called logs, i.e. IP address, domain). We use these data to generate statistics which prove useful in managing the website. The data are of a collective and anonymous nature; they contain no traces that could identify the user. The logs are never disclosed to third parties.

On our behalf, the website www.fsg.pl is managed by an IT Administrator appointed by FSG Biznes. The designated administrator, who is responsible for technical support, has access to your data collected through the website (such as: IP address, first and last name, e-mail address, telephone number).

Data recipients

We never disclose personal data to third parties, organizations, or persons beyond FSG Broker unless one of the following circumstances applies – the user has given their consent thereto.

We provide personal data to third parties, organizations, and persons beyond FSG Broker on condition that the user has given their consent thereto.

We provide personal data to third parties, organizations, and persons beyond FSG Broker if we believe, in good faith, that the provision, use, storage, or disclosure of the data is justified in order to:

- Fulfill the requirements of the law, provisions of legal proceedings, or valid requests made by state institutions,
- Detect and prevent fraud, resolve other issues related to fraud, safety and technicalities,
- Protect the ownership rights or the security of the Personal Data Controller, users accessing the tab www.fsg.pl/broker/oferta-brokerska, and other persons in a manner that is required or allowed by the law.

4. LEGAL BASIS FOR DATA PROCESSING

The legal basis for data processing is:

- The obligation to fulfill legal requirements by FSG Broker. In this case, you must provide your personal data to allow us to perform a task you have requested in accordance with the given topic, e.g. if you do not provide your e-mail address, we will not be able to reply to your request.
- Your consent to having certain groups of data processed for a particular purpose, e.g. to perform a task,
- The obligation to fulfill legitimate purposes of the Personal Data Controller expressed through:
 - managing the tab at www.fsg.pl,
 - customizing its contents to meet your needs and expectations,
 - ensuring the security of your data in the cyberspace.

5. YOUR RIGHTS

You should know what rights you have with regard to the processing of your personal data.

- At any time, you have the right to revoke your consent, which stops the processing of the personal data that have been processed on the basis of the consent previously given. Revoking your consent does not affect the legality of the processing of personal data that have been processed on the basis of the consent given prior to revoking it.
- You have the right to request the removal (right to be forgotten) of the data that concern you from the IT systems and documentation. The right will be exercised by the Controller unless he has a legal obligation to store and, by extension, process the data in spite of you exercising the right to be forgotten.
- You have the right to access your data (right to receive a copy of personal data). The right can be exercised in person by visiting FSG Broker's head office at Plac Andersa 3, 61-894 Poznań, or by contacting our Personal Data Inspector.
- You have the right to rectify the data (update the data). The right can be exercised in person by visiting FSG Broker's head office at Plac Andersa 3, 61-894 Poznań. The act of rectifying the data does not entail their removal prior to the rectification, which results from the obligation to maintain consistency of personal data processed by the Personal Data Controller for a particular purpose.
- You have the right to limit the processing of personal data and object to their processing by referring to a particular situation. The right can be exercised in person

by visiting FSG Broker's head office at Plac Andersa 3, 61-894 Poznań. The right in question will be exercised by the Personal Data Controller unless the action contravenes the provisions of the law that obliges the Personal Data Controller to process the data.

- Furthermore, you have the right to transfer your data from IT systems onto a designated entity, and to lodge a complaint before the office governing the activity of the Personal Data Controller concerning the processing of personal data.

6. SAFETY

We endeavor to protect our users from unlawful access, unauthorized modification, disclosure, and damage to the data held by FSG Broker.

In particular:

- We inspect the ways in which data are collected, stored, and processed (including physical means of asserting security) so as to prevent unauthorized access to the system,
- Access to personal data is granted only to those workers, contractors, and representatives who need it to process the data for our purposes.

7. COOKIES

Cookies are small text data files sent by the server and stored on the computer of the users accessing the tab www.fsg.pl/broker/oferta-brokerska (e.g. on desktop/laptop hard drives, smart phone memory cards, depending on the device used by the person accessing our tab).

Typically, most commercial Internet browsers accept cookies by default. Users can change their cookie settings by accessing browser settings. What it means is that the storage of cookies can be partially limited (e.g. temporarily) or completely disabled.

8. FINAL PROVISIONS

This privacy policy is subject to changes. No user rights under this Privacy Policy will be limited unless the user has given their explicit consent thereto. Any changes to the Privacy Policy will be published at www.fsg.pl/broker/oferta-brokerska; more substantial changes will be announced in a more noticeable way. We archive the previous versions of this Privacy Policy for our users to become familiar with them.
